# 2016 Election Campaign Statements, by Position of Candidacy

### **Candidates for Chair**

### Peter Gillett, Chair

I am asking for your vote as Chairperson of the University Senate. I have previously served on the *Executive Committee* for six years, this last year as Vice Chair, and I now hope to have the opportunity to extend my service to you all. Here is some background:

- 1. After working at all levels including partner in two international accounting firms, I returned to academia, obtained my PhD, and joined the faculty of the Rutgers Business School-Newark and New Brunswick in 1996. I have taught and worked both in New Brunswick (where my current office is located) and in Newark (where my School is based). I have been an active member of the Senate for five terms, working on the *University Structure and Governance Committee* (as Chair or Co-Chair for five years) and on the Budget and Finance Committee. On USGC, I presented resolutions to increase staff representation on Senate, to preserve student representation through reorganization in New Brunswick, and to rebalance the size and composition of the Senate. On Budget and Finance, I spearheaded this year's review of the University Budget. For the past three years, I have been asked by the Chair to serve as the University Senate Parliamentarian. I have been proud and privileged to serve as your Vice Chairperson for the past year, and to represent Rutgers at meetings of the Shared Governance organizations of the other CIC members.
- 2. Beyond the Senate, I have served on the *NB Faculty Council* and its Curriculum Committee, and am the Faculty Advisor to the *Rutgers University Glee Club* and *Kirkpatrick Choir*. I am serving a sixth term as Faculty Secretary and Chair of the Committee on Rules of Procedure of the Rutgers Business School, served on multiple other committees, coordinated our PhD program for five years, and for two years was Academic Director of the *Prudential Business Ethics Center*.
- 3. My three children, my son-in-law, and my daughter-in-law-elect, all graduated from Rutgers, giving me considerable experience as a Rutgers parent, and insights into student life, educational costs, organizational challenges, and the infamous RU Screw.
- 4. # Candidates for RBHS Faculty Member of the Executive Committee

### M. Maral Mouradian, RBHS Faculty Member of the Executive Committee

Dr. Mouradian is a distinguished medical researcher with a history of service to the scientific community and the School. She is the William Dow Lovett Professor of Neurology and Director of the Center for Neurodegenerative and Neuroimmunologic Diseases at the Robert Wood Johnson Medical School. During the last thirteen years prior to joining RWJMS, Dr. Mouradian directed the Genetic Pharmacology Unit of the National Institute of Neurological Diseases and Stroke. Dr. Mouradian's current research focuses on the molecular pathogenesis of PD with an emphasis on the mechanisms by which pathogenic gene products cause neurodegeneration and on the identification of disease modifying therapeutic approaches. She has authored over 200 scholarly publications and edited two books on Parkinson disease. Her research is funded by the NIH, the Michael J. Fox Foundation for Parkinson's Research and other foundations, and she has been recognized for her innovative research by several awards, including form the American Parkinson Disease Foundation and by an NIH Award of Merit. She has been recognized as an elected member of the Alpha Omega Alpha Honor Medical Society, a Fellow of the American Neurological Association and a Fellow of the American Academy of Neurology.

She serves on grant review panels for the NIH and other national and international funding agencies, and is a member of the Scientific Advisory Board of the American Parkinson Disease Association. In addition, she is the Editor-in-Chief of the journal Neurotherapeutics and serves on the editorial boards of several other scientific journals.

Locally, Dr. Mouradian is the Lead Faculty Mentor for Robert Wood Johnson Medical School and serves on the RBHS Faculty Mentoring Committee. She is also a Member of the Liaison Committee on Medical Education (LCME) Self Study Subcommittee for Rutgers-RWJMS. She has been on the Rutgers Senate for the past two years serving on the Research, and Graduate and Professional Education Committee. In addition, she has served on the RBHS Strategic Planning Working Group on Drug Discovery, Development, and Pharmacoepidemiology, Rutgers University Faculty Focus Group for Research Administration Assessment, and as a member of the Steering Committee of TRIGGER (Teeing up Rutgers Investigators for Gifts, Grants, Engagement, and Results). She has also served on the Rutgers-RWJMS Strategic Recruitment Committee, Awards and Prizes Committee, and several search committees for department chairs and other leadership positions She has been serving on the RU Senate as an At-Large Senator of RBHS, with service on the Research, and Graduate and Professional Education Committee (RGPEC).
